The digital ID authentication (DIA) process requires that certain candidates present their primary ID for scanning. This document will help guide you through how to answer the "Reconfirm signatures match" question during the DIA process. Refer to the DIA instructions in the policies and procedures guide and to the exam sponsor's ID policy if you have additional questions.

Starting with item 1 below, answer the question presented. Next, follow the corresponding directions beside your answer to move throughout the document. You are finished when you determine an answer to the DIA question.

Primary ID:
